A RESOLUTION OF THE MOORESVILLE TOWN COUNCIL AUTHORIZING THE TRANSFER OF INTERESTS IN REAL ESTATE FROM THE MOORESVILLE REDEVELOPMENT COMMISSION TO THE TOWN OF MOORESVILLE, INDIANA

WHEREAS, the Mooresville Redevelopment Commission (the "Commission") now owns an interest in the real estate described in <u>Exhibit A</u> hereto (the "Real Estate"); and

WHEREAS, IC 36-1-11-8 authorizes the transfer of real property from one governmental entity to another, pursuant to the adoption of substantially identical resolutions by each entity; and

WHEREAS, the Commission desires to transfer easement rights in the Real Estate to the Town of Mooresville, Indiana (the "Town"); and

WHEREAS, the Town, through the Common Council of the Town of Mooresville, Indiana (the "Council") wishes to accept the easement rights in the Real Estate from the Commission;

NOW, THEREFORE, BE IT RESOLVED by the Council, that:

- 1. Pursuant IC 36-1-11-8, the Council hereby accepts an easement in the Real Estate from the Commission for no consideration.
- 2. The President and any other member of the Council are hereby authorized to take all such actions and execute an easement and all such additional instruments as are necessary or desirable to effectuate the transfer of the easement interests in the Real Estate to the Town.
 - 3. This resolution shall be in full force and effect from and after its adoption.


