

**ORDINANCE NO. 6-2025**

**ORDINANCE OF MOORESVILLE TOWN COUNCIL AUTHORIZING AND  
APPROVING APPROPRIATION OF FUNDS**

**WHEREAS**, the Town of Mooresville (the "Town") is a municipality organized and existing entity under the provisions of Ind. Code 36-5-1;

**WHEREAS**, the Council President (the "Executive") is the Executive of the Town;  
and

**WHEREAS**, the Mooresville Town Council (the "Council") is the fiscal body of the Town; and

**WHEREAS**, at times, it becomes necessary to appropriate additional funds as contemplated and authorized under Ind. Code § 36-4-7-8; and

**WHEREAS**, an additional appropriation of funds is necessary, and the Council has authorized the appropriation of funds from the Opioid Unrestricted Fund #2256 to pay for police computers.

**WHEREAS**, the Council has also authorized the appropriation of funds from the LIT Public Safety Fund #2240 to pay for police computers.

**WHEREAS**, the Council has also authorized the appropriation of funds from the Rainy Day Fund #2236 to pay for IT upgrades.

**WHEREAS**, in order to expend the funds from the above named funds for the above stated purposes, the funds must be appropriated into the appropriate budget line items of the funds; and

**WHEREAS**, the Town has caused notice of a hearing on said appropriations to be published as required by law; and

**WHEREAS**, the public hearing was held on June 17, 2025 at 6:30 p.m., at Mooresville Government Center, Mooresville, Indiana, concerning said appropriations at which time all taxpayers and interested persons had an opportunity to appear and express their views as to such additional appropriations;

WHEREAS, the Town, by its Council has determined that it is in the public interest to now appropriate such funds accordingly.

NOW, THEREFORE, BE IT RESOLVED BY THE MOORESVILLE TOWN COUNCIL, AS FOLLOWS:

1. The foregoing recitals are incorporated herein by reference.
2. The following sum of money is hereby appropriated from the Opioid Unrestricted Fund #2256 for the purposes specified, subject to applicable laws, as follows:

**\$50,000.00 –Opioid Unrestricted Fund #2256**

3. The following sum of money is hereby appropriated from the Rainy Day Fund #2236 for the purposes specified, subject to applicable laws, as follows:

**\$100,000.00-Rainy Day Fund #2236**

4. The following sum of money is hereby appropriated from the LIT Public Safety Fund #2240 for the purposes specified, subject to applicable laws, as follows:






