This motion carried.

Charles Hillman was heard next with his plan for operating his Recreation Room on Sunday. Mr. Hillman was advised by the Trustees that they felt that for the continued good-will of the townspeople, he should keep his business closed, but the Town had no Ordinance against such Sunday opening and Mr. Hillman would have to decide this problem for himself. Mr. Hillman stated that he was going to try the plan of opening from non-church hours on Sunday and note the reaction of the citizens and if he found it to be unfavorable he would keep his business closed thereafter.

The Board of Trustees of the Town of Mooresville, Indiana met in continued session in the Municipal Building with all members responding to roll call. Attorney Butler was also present at this meeting.

The minutes of the meeting of December 2nd were read. It was moved by Gregory and seconded by Shepherd that these minutes be acceptable as read and the motion carried.

Among our visitors were the Trustees of the Mooresville School Corp. namely Mr. Alvin Scott, Mr. Franklin Jones, Mr. Fred Glidden Trustee Brown Twp. and Harvey Laughlin, School Sup't. with their Attorney Mr. Hugh Couch. Mr. Couch represented the School Board in giving a synopsis of the action of the Board who on the 4th of December, 1952 received a petition of 145 signatures for the addition of 6 new rooms to the Newby Building and the Board did thereby adopt a resolution to use the accumalative fund for building which had attained the approximate amount of \$70,000.00 and to create a bond program indebting the School in the amount of \$70,000.00 with the bonds to retire in 12 years. Mr. Couch presented a resolution for the Board of Town Trustees consideration for the approval of the resolution of the School Board made on the 4th of December. It was moved by Allison and seconded by Rushing that the Board of Town Trustees approve the action taken by the Board of School Trustees. This motion carried and the Resolution was thus signed by the Town Board members and attested by the Clerk-Treasurer.

Resolution No. 8 was read next allowing and requesting a transfer of \$4000.00 from the Parking Meter Fund to the Town General Fund and in addition the transfer of \$1.04 from the Milk Inspection Fund to the General Fund. It was moved by Rushing and seconded by Gregory that the resolution be passed and adopted. This motion carried.

The matter of appointments came up next. It was moved by Allison and seconded by Rushing that all employees and officers of the Town be retained for the year 1953. This motion carried. A discussion arose on the difficulties which had arisen from the past year in respect to the low hourly wage of 75¢. It was finally moved by Allison and seconded by Shepherd that the hourly rate of pay for all town employees be established at \$1.00 per hour for work done in 1953. This motion carried.

The Board of Trustees of the Town of Mooresville met in regular session in the Municipal Building on Tuesday January 6th, 1953 with all members responding to roll call. Minutes of the meeting of December 30, 1952 were read and it was moved by Allison and seconded by Rushing that theses minutes be acceptable as read. Motion carried.

Resolution No. 1 of 1953 was read for the first reading allowing the salaries of the Police Dep't. in the amounts of \$255.00 for Police No. 1, 235.00 for Police #2, and \$220.00 for Police No. 3 and the P. Meter Police. It was moved by Allison and seconded by Gregory that this resolution be passed and adopted. This motion carried.

The matter of the appointment of an attorney for the Town for the year 1953 was brought up next. Moved by Shepherd and seconded by Rushing that Mr. Gilbert Butler be retained to serve for the mentioned period. This motion carried.

A question arose next concerning the Permanent Maintenance Cemetery Fund and as to the possibility as to funds contained to be usable for the buying of additional land for cemetery purposes. The present Mooresville Cemetery has become almost completely filled and the need was cited for an emergency action. The Clerk-Treasurer was instructed to contact Mr. Butler in conern of this matter and inquire as to State Laws governing permanent maintenance funds. This report to be made with the February meeting.

Discussion followed concerning the anticipated purchasing of the Town's police car. The specifications having been decided upon in the December meetings, no further additions or subtractions were mentioned. The Trustees instructed the Clerk-Treasurer to have said notice to car-bidders published in the two county newspapers. It was stated further by President Fields at this time that the meeting would be in continued session until the 19th of January at which time the Board would receive sealed bids on the police car and consider them at that time. Further discussion led to insurance which would be a necessity for the car. Anumber of agencies were mentioned and it was agreed by all members that the car insurance should be allowed to an agency which has not had the opportunity for a policy covering any Town possessions. It was moved by Allison and seconded by Rushing that the Coleman Agency be given the right for insuring when the time came to do so. Motion carried.

A matter brought forth next was the proposal for the removal of the telephone from the fire station. The Trustees felt this to be an unnecessary expense due to the fact that Mooresville had no regular stationed department members and therefore the phone could be of little or no use. Indiana and E. Wash. sts being reversed in the stop with the stop coming from the east and west bound Washington St. The second condition prevails at Monroe and W. Harrison where the north and south bound Monroe St. commands the stop of Harrison St. The Board asked that a check be made for the use of additional stop-signs and that more be ordered as soon as possbile. This action made in the form of a motion by Shepherd and seconded by Rushing. This motion carried.

The Board of Trustees of the Town of Mooresville, Indiana met in regular session in the Municipal Building on Tuesday April 7th at 8 P.M. with all members responding to roll call. Attorney Butler was present at this meeting also.

The minutes of the meeting of March 3rd were read and it was moved by Gregory and seconded by Shepherd that these minutes be acceptable as read. Motion carried.

The Treasurer's report was read showing a balance of all funds to total \$30,953.61. It was moved by Allison and seconded by Rushing that the Treasurer's report be acceptable as read.

Kenneth Dorsett was present reporting a bad condition of the alley to the rear of Dorsett's property on W. High St. The Trustees explained to Mr. Dorsett that work of grading the alleys would commence in the very near future and this poor condition would be eliminated.

Cecil Bain was heard next with an inquiry as to any program operating in the Town relative to the National Civil Defense Program. The Board informed Mr. Bain that they knew of no such program and would welcome any interested party to develop such a program. Mr. Bain interested in a Boy Scout participa tion was thanked by the Trustees for his interest.

The question of the discontinuance of the garbage collection due to

a newly created State Law preventing the feeding of raw garbage to swine was brought up for discussion. Mr. Horton Stanley collected garbage twice in March and had to quit. It was the Board's decision to contact Mr. Stanley and see to the possibility of his obtaining a garbage cooker and the Board raising his fee for collection. It wasnoted that the local scavenger service was picking up a considerable amount of the garbage from the street fronts and the Board instructed the Clerk-Treas. to write Mr. Don Freeman, a representative and ask that he have his customers place their cans for an alley pick-up service.

Rev. Ted Rigdon had made know his request fo r the revival of the curfew ordinance in Mooresville which would require all children under 16 years of age to be off the Town streets by 9:30 P.M. The Board discussed this matter and decided to table any action for the time being. Mr. Rigdon did ask that an amendment be made to this Ordinance to allow the children to be out until 10:30 PM.

In response to discussion in concern of a street contract program for this summer, the Board decided on a meeting in the very near future for inspection of the Town streets and setting out specifications for repair of the most damaged streets and alleys. A work order was issued for the change about of the stop-signal signs on N. Indiana st. to be reversed and placed on W. Washington St. and also the moving of the town limit sign on N. Indiana St.

In response for requests for estimates two bids for the cleaning of the septic tanks were examined. The first one being that of the Max Haas Co. who agreed to clean the West tank for \$450.00 and the east tank for \$900.00. The second bid called for \$225.00 on the west tank and \$425.00 on the south tank. It was moved by Shepherd and seconded by Allison that to remain within the budget appropriation only the south tank be cleaned this year and the west tank to be set out for next year and to contact Allender and Weddle the second bidders and inform them, the Board wished them to do the work providing their bid included hauling away of the sludge. The Board of Trustees of the Town of Mooresville, Indiana met in regular session in the Municipal building with all members present with the exception of Harmon Allison on Tuesday May 5, 1953 at 8 P.M. Attorney Butler was also present at this meeting.

The minutes of the meeting of April 7, 1953 were read and it was moved by Rushing and seconded by Shepherd that these minutes be acceptable as read. Motion carried.

Next the Treasurer's report was read showing a balance of all funds to total \$30,205.65. It was moved by Shepherd and seconded by Gregory that the Treasurer's report be acceptable as read. This motion carried.

Mr. E. F. Hadley was present with a plat of the proposed third addition to the Town of Mooresville and presented a resolution for the adoption of this third addition for the approval of the Board of Town Trustees Since this matter had been presented at the April meeting for consideration it seemed that no further discussion was needed and it was moved by Shepherd and seconded by Rushing that the Hadley Third Addition be added to the limitations of the Town. A vote was taken which proved a unanimous decision. Thus the resolution was passed for signatures and the plat ready for the records at Martinsville Courthouse. A plat was furnished the Town by Mr. Hadley for the files in the Clerk's office.

A question concerning two proposed fire plugs in Hadley's third Add. were brought up next and it seemed proper after discussion that these plugs should be installed at this time when the regular water lines were being laid to cut down on additional costs later, so it was moved by Rushing and seconded by Shepherd that the Clerk-Treasurer be instructed to issue a letter of authorization for the addition of two fire hydrants in the Hadley third addition. This motion carried.

The matter of the downspouts which are connected to the town sanitary sewer was the next problem brought up. Since as stated in the March meeting a town inspection would be made with the first of May, it was decided that Mr. Homer Monday, Fire Chief and Leonard Horton, S_{\pm} . Commissioner would be instructed to make the inspections and have a report ready as soon as possible.

Attorney Butler in response to a request by the Board for a trial Ordinance which would make for better living conditions with persons living in trailers and in trailer courts and the like, presented an outline of an Ordinance suitable for a town the size of Mooresville. A few recommendations and suggestions by both Mr. Butler and the Trustees will make a probable first reading of such Ordinance at the June meeting.

A letter was read from Dr. Kenneth Comer asking permission of the Board for a leave of absence of one month the latter portion of June for Richard Keller, Marshal, for the reason of driving a bus load of Sunday School Boys to a ranch in Wyoming. Mr. Horton was instructed to have Mr. Lusty proceed with the erection of the signals after discussion by the Trustees.

As had previously been discussed in concern of this matter, there was one bid for the repair-of same by the Harry E. Wilson Construction Co. in the amounts of \$46.90 for the Municipal Building, \$8.40 for mopping the storage Bldg. roof, and \$226.80 for repairing around flashing and putting on (2) 151b. felts and 3 moppings of asphalt on roof of Fire Dept. The Board of Trustees of the Town of Mooresville, Indiana met in continued session on Monday August 31st at 8 P.M. in the Municipal Building with all members responding to roll call. The purpose of this meeting as stated by President Fields was for the purpose of hearing the views of the local citizens relative to the budget for 1954 prepared by the Board of Town Trustees.

There were no citizens present in concern of the budget.

The Ordinance calling for the 1954 Budget of the Town of Mooresville drawing a total rate of \$1.997 was thus given the second reading. It was moved by Rushing and seconded by Gregory that the Board pass and adopt this Budget. This motion carried unanimously.

Schulyer Spoon was present in concern of the water and sewer problem in the northeast section of the Town. Quite a lengthy discussion followed and Mr. Spoon was invited to participate in the next meeting of the Board which will be on the 1st day of September.

This meeting being finished in its purpose for the evening, it was moved by Allison and seconded by Shepherd that the meeting adjourn. This motion carried.

The Board of Trustees of the Town of Moorestille, Indiana met in regular session in the Municipal Building on Tuesday September 1st at 8 P.M. with all members responding to roll call. Attorney Butler was also present at this meeting. In addition were several local citizens and Mr. Bennett of "The Times".

Minutes of the meeting of July 28th were read. A correction in these minutes was made wherein an error had been made in posting the rate as called for in the 1954 budget from the reading of \$1.977 to the correct figure of \$1.997. After correction it was moved by Harmon Allison and seconded by Shepherd that these minutes now stand. This motion carried.

The above mentioned visitors namely Schuğler Spoon, Arnah Wilson, Wm. Prather, Glen Poe, Leo Holland and Mr. Mendenhall along with Mr. Phil Bennett were present in regards to a problem of securing a sewerage system and a water system for the various homes of each as well as for the entire community in the northest section of town now without such facilities. During the discussion following, Attorney Butler explained several questions to the group about financing such a project which would have to be either by the revenue bond or the Barrett system, the cost relying upon the user securing the water and sewer service unless an entire new disposal system or plant had to be raised to care for the extra processing of sewerage and then a probable taxation would be placed upon the entire population of Mooresville, but for the disposal unit only. It was further suggested that the entire ownership of homes in the area affected by any such sewer and water program be contacted before any excessive steps were made any further. Mr. Spoon acting as spokesman for the group stated that they would like a meeting again with the Town Board to present a petition bearing signatures favoring the installation of the sewer and water system. The Board of Town Trustees suggested that a joint meeting with the citizens as well as Mr. Wilson Přes. of the Water Company, Mr. Taylor local representative, and Mr. Russell B. Moore of the engineering firm making a sewer survey for the Town of Mooresville in its entirety in 1944-45, and these gentlemen be invited to participatin such a meeting on the 6th of October, the next regular meeting date. This suggestion found favor with all.

Next a letter of resignation from the Board of Town Trustees was read representing Kenneth Fields. Due to congestion in his business, Mr. Fields found it necessary for the choice of resignation. Reductantly, the Board of Tustees accepted the resignation in the form of a motion made by Roy Rushing and seconded by Harmon Allison. There was no appointment made at this time to fill the vacancy left by Mr. Fields resignation which called as the effective date of September 7, 1953.

The matter of the street repair program was brought up next. Mr. Horton, St. Commissioner stated that Mr. Hargis had been contacted a number of times in reference to his contract with the Town, but as yet no appearance had been made by the company for the resurfacing of the street s in question. The Board instructed the Clerk-Treasurer to again contact Mr. Hargis in reference to this matter. In addition Mr. Allender and Weddle the sewer cleaners with whom a proposition was signed in April for the cleaning of the east Septic tank. No appearance has been made to date by these gentlemen to fulfill their proposal. Along with the discussions on the streets and sewers, a dangerous situation had been called to the attention earlier in the evening of the dead end of the St. Clair Street on the west which terminated in Goose Creek. No barricade or warning is present at the end of the street and it was moved Shepherd and seconded by Allison that a barricade be erected at the end of St. Clair Street on the West.

The claims for the month were brought forth next for reading for consideration of payment. After hearing the claims, it was moved by Rushing and seconded by Allison that all claims be allowed with the exception of the bills of the W. C. Hargis Co. until further contact be made with Mr. Hargis. Allother claims were allowed as read which were:

The Board of Trustees of the Town of Mooresville met in regular session in the Municipal Building on Tuesday October 6, 1953 at 8 P.M. with all members namely Harmon Allison, Herman Gregory, Roy Rushing and Elvin Shepherd responding to roll call. Attorney Butler was present at this meeting as also were Mr. Wilson and Mr. Holland of the Hoosier Water Co. and Mr. Fred Heger representing the firm of Moore and Heger Engineers. Representatives of these companies had been invited to meet with the Town Trustees in the interests of the citizens of the northeast section of Mooresville petitioning for a sewer and water system to their homes.

Minutes of the meeting of September 1, 1953 were read and it was moved by Shepherd and seconded by Gregory that these minutes be acceptable as read. This motion carried. Due to the vacancy in the presidency of the Board with the resignation Kenneth Fields, the Clerk-Tressurer appointed Harmon Allison to serve as the President Pro-Tem and passed these minutes to Mr. Allison for his signature of approval.

Mr. Allison next stated that nominations were in order for an appointment to fill the vacancy of Mr. Fields. It was stated that a number of contacts
had been made in this matter but all persons show reluctance to serving.
The name of Harry Wilson was placed in nomination by Herman Gregory. There
were no other nominations and the motion was made by Elvin Shepherd that
the nominations be closed with a second by Roy Rushing. Thus Harry Wilson
was appointed to serve the full-fillment of the term of office of Kenneth
Fields, the same being to December 31, 1955 or until a successor shall be
elected to fill the post. Mr. Allison suggested that Mr. Wilson be contacted
by phone of his appointment and be asked to sit in on this meeting, to which
Mr. Wilson consented.

Next a citizen Glen Smoot requesting a load of gravel for an alley was heard and the matter was turned over to the Street Commissioner.

Mr. E. F. Hadley was present stating that the sidewalk had been extended on N. Indiana St. to Haltom Street and asked that the Board accept it now for public use. It was moved by Shepherd and seconded by Rushing that the sidewalk thus be accepted, and this motion carried.

While the officials of the Water Company retired, Mr. Heger was invited to explain steps as to what might be necessary to resume pick-up points to the original plan of Moore and Owennwhich was made for the Town in 1945 in reference to a new sewer system with a new sewerage disposal plant. Mr. Heger spoke to the group of citizens representing the petitioning group as well to the Town Trustees. The original plans could not be fully used as new additions have been added to the town which were not included with the original master plan. Mr. Heger advised that his organization would re-study the plans and take in consideration the status of the town corpopation now and revise the sewer plans, if the Board so wished. The Trustees thanked Mr. Heger for his time and aid in the matter and suggested that the Board be given a short while to make additional plans and contact the Moore and Heger firm at a later date in regards to any further study.

Mr. Wilson who is also the head of an engineering firm on town problems such as sewering and disposals systems spoke next, but with more relationship to the procedure of water installations and explained many rules of the Public Service Commission under which they operated the Hoosier Water Co. Mr. Taylor the local water representative was present and added to the discussion.

While, the Town Trustees have no jurisdiction over any of the water installations other than for the placing of fire hydrants, it was to their interests that Mr. Wilson did proceed to help the citizens in their questions on their home installations and it would seem quite inadvisable to preced with a newer plan unless a suitable water system could be worked out. Mr. Wilsonsfurther vexplained idesired plans for the rerection of a water tower which could make service to Mooresville citizens much more secure and afford better fire protection. Due to the lateness of the hour it seemed advisable to call another meeting at a later date for further discussion. The Board thanked Mr. Wilson, Holland and Taylor for their graciousness in appearing at this meeting.

Schuyler Spoon and Arnah Wilson representing the citizens requesting the sewer presented a petition for such bearing approximately 167 names

which will remain on file in the Clerk's Office.

Additional meetings will be held in the future in respect to the planning for the new sewer system. Attorney Butler advised a meeting inviting all, citizens so that all points of such a program could be fully explained and understood as to obligations for all concerned, the method of paying such a project and the like so that when the details commenced to be worked out, proceedings could be carried on as hurriedly and economically as possible. Dates of meetings to be announced and published in the local news-

Harry E. Wilson, -newly appointed trustee of Ward No. 1. was administered the oath of his office by the Clerk-Treasurer and thus became eligible for active participation in the meeting.

Petition No. 1 for the request to park a trailer was read from the applicant of Harry Mitchell of S. Indiana and South Sts. The application was in proper form, but did not carry the fee required of \$5.00. Inspection of lot to be made by Chief Shaw and a report be made, but no permit thus issued without the receipt of the usual fee.

It was moved by Roy Rushing and seconded by Harry Wilson that all trailer positions within the corporate limits be inspected as well as any lots bearing huts and shanties and a report be made as to those not meeting the articles of the recent ordinance on the regulation of such.

Harry Wilson brought forth the suggestion next that the matter of annexation of a large portion of contigous property as well as many cases of township property inside the town limits be incorporated to the present limits of the town since all were benefitting in a like matter with the townspeople but paying only township taxes. Mr. Wilson felt that these steps should be taken immediately to which fellow-trustees unanimously agreed to insure a better organization of fair distribution for all the community. Further steps on this matter to be taken up with the November regular meeting.

The claims were read for the consideration of payment of same. All claims were allowed with the exception of the W. C. Hargis claims which were to be supplied with some missing delivery tickets before warrants were issued. The matter of the non-receipt of the bill for water service was allowed due to the fact that the bills are not issued until the 10th of each month. Claims were:

Schuyler Spoon Jr. and Arnah Wilson representing citizens on Carlisle and St. Clair Sts. were present asking that a new foot-bridge be constructed over GooseCreek on St. Clair St. The Board of Trustees stated that materials were being secured for the bridge and it would be in the process of completion during the week. A suggestion from Mr. Spoon for the making of a bridge for truck accommodation was discounted due to unavailability of funds for an appropriation of this size.

Mr. Kenneth Dorsett, delegated from the Libns Club arose at this time stating the Club's approval of additional plans being made in concern of a sewer project for the northeast section of the Town.

Mr. Harry Wilson speaking in behalf of Town Trustees stated that progressive steps were being taken in the sewer project in that the unanimous decision of the Board rested in that the town limits should be specifically designated which would include some additional areas being included as well as some properties located within the town, but being assessed to the Brown Township and with all boundaries established, then a definite sewer survey could be made in regards to the recent petition. Mr. Delbert Hobson who has been conducting a survey for establishing the Town boundaries, was present and during the discussion which followed, it was decided that the Town Trustees along with Jesse I. Wilson, Brown Township Trustee and Mr. Hobson would meet the first of the week and proceed to locate the final boundaries of the town for a proposal in the form of an Ordinance to be presented as soon as possible to the citizens of the Town. Along with the establishing of the town limits would come the problem of zoning which would be taken up then.

To afford better accommodations to the Public in conjunction with the installation of the vault for night depositories in the local bank, it was agreed that the first meter on the east side of South Indiana St. be removed and a parking zone be established in its stead for the use of those citizens wishing to make deposits in the bank. The sign to be erected and worded thus "Bank Deposits Only"- 5 Min. Parking." This proposal made in the form of a motion by Rushing with a second by Shepherd and a unanimous favorable vote.

Trailer Application #2 was read as submitted by Fred Haltom living on Indianapolis Rd. asking permission to park 3 additional trailers on his lot. Application to be referred to Chief Shaw for verifications.

A letter was read from Mr. Frank H. Taylor, Sec. of the Morgan Co. Plan Commission offering the services of their building commissioner for the town of Mooresville. The Clerk-Treasurer was instructed to acknowledge the offer stating the Town to be without zoning ordinance at the present, butreveal plans for forthcoming zoning of town.

Among items included in general dizcussion which followed was the greater number of complaints being received as a result of customers illegal parking while in the tavern. A notation to be made to the local officers for closer watch on alley parking and an appeal to be made to Forest Dake, tavern owner.

William Cox delegated from the Memorial Ass'n. was present asking that an investigation be made in the disposition for a request of 3 or 4 years ago by the Memorial Ass'n. to the Town Board for the change of a street name of Kelley Street to Memorial Drive.

The matter of the appointing of a Board President was taken up next. The Board of Trustees has been served by a President Pro-tem since the resignation of Kenneth Fields in September. The Clerk-Treas. stated that nominations were in order for the nominating of the President. The name of Harry Wilson was brought forward by Elvin Shepherd with a second by Herman Gregory.

There were no other nominations and Roy Rushing moved the nominations be closed with a second by Elvin Shepherd. Roll Call resulted in a unanimous decision as Harry Wilson taking the President's chair.

Mention was made of the bad condition left on West Main St. by the new drive made into the Friends Church grounds from the rear of the property onto W. Main St. The Trustees instructed the Clerk-Treasurer to write a letter to the Trustees of the Friends Church asking that some of the earth be removed and some work be added to the approach which would keep the dirt from washing away onto W. Main Street.

The claims were presented next for reading for consideration for payment of same. After hearing the claims it was moved by Shepherd and seconded by Rushing that all claims be allowed as read and warrants drawn for them. The claims were:

The Ordinance was then given its second reading before the Trustees. There were no citizens present to protest the matter. This motion carried, and the Ordinance was passed for the signatures of the Town Trustees being attested by the Clerk-Treasurer.

A number of small problems were discussed concerning, street and sewer work before winter weather began.

Business being completed for the evening it was moved by Rushing and seconded by Allison that the meeting adjourn. This motion carried.

Mooresville, Indiana December 1, 1953

The Board of Trustees of the Town of Mooresville, Indiana met in regular session on Tuesday December 1, 1953 in the Municipal Building with all members responding to roll call with the exception of Elvin Shepherd. Attorney Butler was also present at this meeting.

The minutes of the meeting of November 3rd and 10th respectively were read. It was moved by Allison and seconded by Rushing that the minutes of November 3rd be approved as read and this motion carried. Next the minutes of the meeting of November 10there read and it was moved by Gregory and seconded by Allison that these minutes too be acceptable as read. This motion carried.

The Treasurer's report was read next showing a balance of all funds to be \$27,525.29. It was moved by Allison and seconded by Rushing that the Treasurer's report be acceptable as read. This motion carried.

A number of citizens were present at this meeting with various suggestions and complaints. The first citizen to be heard was Harold Hawkins a local Scoutmaster reporting a number of bad conditions of the Scout Cabin at the Town Park. Along with Mr. Hawkins was Mrs. Martha Sage, representing the Girl Scouts. Both representatives explained the need for a new roof, repair to the floor, better window protections, repair to guttering and installation of better safety facilities. Examination of funds for the park use were examined by the Town Trustees and it was found to show a balance of \$2196.81 which the trustees felt would allow for repairs needed for the cabin to be more usable. It was moved by Rushing and seconded by Gregory that the Park Committee consisting of Harmon Allison and Elvin Shepherd supervise the necessary repairs to be made to the cabin. This motion carried.

Marie Clift was hear next reporting the unsafe condition to the approach to the first alley on Franklin St. east of State Rd. #67 by the presence of a large maple tree nearing the center of the alley. She asked the Town's assistance in having the tree removed. The Board of Trustees instructed Leonard Horton, St. Commissioner to attend to having the tree removed since recent surweys revealed the tree to be in the alley.

Schuyler Spoon and Arnah Wilson were present in concern of the bridge for footuse over Goosecreek on St. Clair St. Schuyler Spoom inquired of Attorney Butler if any maoney was available for the construction of a better bridge from the use of the county bridge fund. Mr. Butler advised that he had consulted the County Auditor and to date no funds had been released for work of any kind.

In anticipation of the alley work to be done with the permit of suitable weather, Glen Smoot and Charles Flater were present in concern of the boundary lines of alley lying from W. High St. to South St. and dividing the Smoot and Flater properties. The Town Trustees are completing the contract work on the streets and alleys for the year 1953 and all alleys are to be made as surveys call for. Mr. Flater was concerned with a survey establishing the alley onto his property or which he assumed to be his property. A county survey revealed the decision and the Board of Trustees agreed to another survey if Mr. Flater so desired. The removal of some shrubbery seemed to be the problem in question. Mr. Flater stated that he did not wish to go into any expense in establishing another survey. Mr. Flater was further advised that another consideration would be made by the Board members and they would meet with him at his home the following morning to review the situation, but that the alley would have to be cleared according to the survey. Mr. Smoot's problem was the request to protect a shade tree in his back-yard which rooted into the alley. The Board assured Mr. Smoot the tree would not be damaged.

Mr. Haltom living on Indianapolis Rd. and Mr. Harry Mitchell of South Indiana St. were present in concern of the placing of trailer applications at an earlier date. The trailer applications were taken up with the Town Trustees at this time. Officer Shaw reported that he had investigated all applications and he found conditions allowable for the placing of 5 trailers on the Haltom property instead of the 6 as requested. After explanations Mr. Haltom found this suggestion aggreeable. Chief Shaw reported that Mr. Mitchell's conditions did not meet with the provisions of the Trailer Ordinance and therefore he suggested the refusal of the trailer permit. Mr. Shaw reported further that the present existence of 2 trailers on a lot with the dwelling of the Mitchells was a violation of the said Ordinance before the application for another trailer was received. The Application of Mr. Mitchell did not carry the \$5.00 permit and application fee; therefore there were no refunds to be made. Town Trustees instructed Chief Shaw to meet with Mr. Mitchell at a later date and see if he could work out an arrangement with Mr. Mitchell to avoid violations of the Trailer Ordinance on the present set-up. Chief Shaw reported the 3rd and 4th applications of Mr. James Vaughn and Mr. Veldia McCoySr. respectively to meet specifications and the Town Trustees instructed the Clerk-Treas. to issue permits to them for the placing of one trailer each.

Mr. Jack Mackenzie was heard next after an invitation from the Town Trustees was received for attendance at this meeting in concern of the drafting of better cemetery maps for the Town. Eximanations of the existing maps was made and with the enormous amount of work to be involved in a project of this kind, Mr. Mackenzie advised the Board that he would give them an answer at a later date.

Mr. Delbert Hobson conducting the survey for the Town which will establish the new town limits was present and showed the Trustees the extent of his work to date. Mr. Hobson advised the Board Members that he expected his drawings with good weather permitting to be ready for the making of the Ordinance by the end of December, 31st.

Numerous needs for sidewalk repair were brought up next with the extreme need for the repairing of the walk over Goosecreek on N. Indiana St. near the 2nd Hadley Addition. Members of the Street Comm. were instructed to having this walk repaired at the earlierst date possible.

Further town problems discussed brought the instructions to the Clerk to write letters to all excavators of sewer ditiches in Moores ville to not approach the Town main sewer lines within a distance of 5 ft. with any mechanized equipment. A need for 2 small punching bags and a ping-pong table were cited in the local recreation program. The Recreation committee to be consutted further on this matter. Instructions were given the Town Clerk to inform Mr. Henderson the Septic tanks of

the Town to be attended only once each week and Mr. Henderson to never

go alone to the septic tanks due to the danger involved. Allowance of \$2.00 per week per tank was allowed. Further 2 hours per day were to be allowed Mr. Henderson for maintenance about the Municipal Building.

The claims were read next for consideration for payment. After hearing the claims, it was moved by Rushing and seconded by Gregory that all claims be allowed as read and warrants made for them. With the completion of the additional appropriations the sewer bills to be made allowable also. The claims as read and allowed were:

The Board of Trustees of the Town of Mooresville, Indiana met in continued session on Tuesday December 29, 1953 at 7:30 P.M. in the Municipal Building with all members responding to roll call with the exception of Harry Wilson who was not present at the time of roll call, but was counted present later in the meeting.

Mr. RoyuRushing was appointed to fill the chair as President Pro-Tem prior to Mr. Wilson's arrival at the meeting.

The minutes of the meeting of Dedember 1, 1953 were read and it was moved by Gregory and seconded by Allison that these minutes be acceptable as read and this motion carried.

Jack Mackenzie was present advising the Board of Trustees that he would proceed with the making of the cemetery maps which the Board had contacted him earlier in the month. He asked the help of a surveyor in establishment of correct lines and any additional help from the cemetery sexton or the Town Clerk. It was moved by Allison and seconded by Shepherd that Mr. Mackenzie proceed with his project of the making of the cemetery maps. This motion carried.

The appointments of town employees and officers came next with the first being that of the Town Attorney. It was moved by Gregory and seconded by Allison that Mr. Gilbert Butler be retained to serve the Town as its attorney for the year 1954. This motion carried. In the matter of the Police Department, it was moved by Shepherd and seconded by Allison that all the police be retained in the same status as 1953 and Mr. Horton to serve as the Parking Meter Police and the Street Commissioner. This motion carried.

In concern of the organization of the fire Department, Fire-Chief Homer Monday advised that the Department was in need of two additional firemento meet the standards set up by the state office which would bring our total number to 15. It was moved by Shepherd and seconded by Gregory that the appointments be made to meet the state's standards and the names of Bill Taylor and Clarence Squires be added to the list of firemen now serving the Town of Mooresville. This motion carried.

In the matter of the employ of Milton Henderson who serves the Town in Miscellaneous capacities it was moved by Harry Wilson and seconded by Herman Gregory that Mr. Henderson's rate of pay be \$1.00 per hour and the time to be kept by the Street Commissioner on the Street work with the allowance of 2 hrs. per day for maintenance about the Municipal Building and 2 hrs. per week per each septic tank, This motion carried. It was also mentioned at this time that Hried Horton Would be responsible for the time keeping of every man hired to work for the street department during the year 1954 and the time to be reproted each month at meeting time.

Several small town problems were taken up next with the first being that of the repair of the Scout Cabin in the Park. The Board deemed it advisable to obtain estimates on the cost of repairing the Cabin before any work should be started. Investigations to be made for the possibility of the removal of the chapel-house in the cemetery which is in very poor condition. The matter of the ordering of any equipment for the recreation department for the boxing project was tabled until further notice.

The Clerk-Treasurer reported that Mr. Holland of the Hoosier Water Co. had called earlier in the afternoon and akked that the

matter of the erection of a water-tower be discussed by the Board and also the possibility of the erection of the said tower to be made on the lot belonging to the Town of Mooresville and lying directly south of the Municipal Building. This matter being brought forth was very thoroughly discussed and at length it was decided unanimously that in the best interests of all town citizens for the future use of the vacant lot, the use of the lot for the erection of the water-tower should be discarded athis time. The Clerk-Treasurer was so informed to notify the Hoosier Water Co. of their decision, expressing their regrets in this decision.

An inspection of the trailer lots or any lot upon which a trailer was arked was asked for and the inspection to be made by the Chief of Police just as soon as possible.

The matter came up next in concern of the County Zoning Board newly instituted and the relationship with the Town of Mooresville. After discussion by the Town Board members they deemed it advisable to dispel with plans for a town zoning law and independent Board and to rather seek control under the laws of the county zoning Board. This matter to be discussed further at a later date.

St. Commissioner reported that he had need for 8 more stop signs to be placed at intersections and the Board of Trustees instructed the Clerk-Treas. to attend to the ordering of these signs.

The Clerk-Treasurer reported that she had contacted the State Board of Accounts relative to the transferring of funds from the contingency fund to the OASI. Fund to cover the Town's portion of payment for the employees and the State Board of Accounts had given their sanction to the following resolution as approved. Transfer of the following amounts from the Contingency Fund to be made to the O.A.S.I. Fund.

Next the claims were presented for consideration for payment. After hearing the claims it was moved by Shepherd and seconded by Gregory that the claims be allowed as read and warrants drawn from the Treasury for them.
