- 6.1 The office renovation project is nearing completion, with just a few finishing touches remaining. Kitchen cabinets have arrived, and final measurements for the countertops were made early last week, with installation expected by the end of May. The epoxy flooring contractor is scheduled to start work on the Oak Room floor on May 19. The project remains under budget, with total expenses exceeding \$72,400, leaving approximately \$2,548.56 of the \$75,000 budget unspent.
- 6.2 Weekly meetings with the project team take place every Friday morning to discuss all components of the BOT Pioneer Park project. Currently, the focus is on utility coordination and permitting, with construction scheduled to begin in the last two weeks of May. A press release is prepared for publication next week, and a ground-breaking ceremony is tentatively planned for the week of June 9.

NEW BUSINESS

7.1 The board President will formally sign and authorize the petition to the Town Council for the annexation of 531 E County Line Road property, with two public hearings to complete the process.

- 8. DEPARTMENT REPORTS
 - 8.1 Assistant Superintendent Report
 - 8.1.1 RECU's last day will be Thursday, May 22. Appreciation was expressed for the staff's efforts in making the program successful and for Telly's commendable work in her first year. Camp registrations are underway, with no caps planned, ensuring more than enough space and staffing. Swimming lessons are about 70% full, with some popular sessions already filled, but early sessions still have openings.
 - 8.1.2 The pool is ready to open on Saturday, May 17.
 - 8.1.3 The first summer concert is scheduled for Friday, May 16, at Pioneer Park, with the first Bicentennial concert on Thursday, May 29.
 - 8.1.4 Staffing is fully accounted for the summer, with the following hiring numbers reported: Lifeguards: 38 hired, 32 needed. Concessions: 25 hired, 25 needed. PAC Camp: 15 hired, 15 needed. REC Camp: 15 hired, 15 needed. Park Maintenance: 2 hired, 2 needed.
