**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MOORESVILLE,
INDIANA DECLARING CERTAIN PERSONAL PROPERTY TO BE SURPLUS**

WHEREAS, the Town Council of the Town of Mooresville, Indiana ("Town") has determined that certain property owned by the Town is no longer needed and should be declared surplus; and

WHEREAS, Ind. Code § 5-22-22 *et seq.* authorizes the Town to follow certain procedures to dispose of surplus property; and

WHEREAS, in accordance with Ind. Code § 5-22-22-10, surplus items may be exchanged with another governmental body upon terms and conditions agreed upon by the governmental bodies.

WHEREAS, the Morgan County Sheriff's Office, located in Martinsville, Indiana ("County Sheriff"), agrees to purchase surplus property from the Town.

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE
TOWN OF MOORESVILLE, INDIANA AS FOLLOWS:**

Section 1. The above recitals are incorporated herein by reference.

Section 2. The vehicle listed in **Exhibit A**, attached hereto and incorporated herein by reference ("Vehicle"), belongs to the Town and is no longer needed and/or are unfit for the purposes for which they were intended.

Section 3. The Vehicle listed in **Exhibit A** is hereby declared surplus property.

Section 4. The Town agrees to sell the aforementioned Vehicle to the County Sheriff for Twelve Thousand Dollars (\$12,000.00). Payment will be made by check upon transfer of the Vehicle.


Section 5. The Vehicle is sold as-is, with no warranties or guarantees expressed or implied by the Town. The County Sheriff has had the opportunity to inspect the vehicle and accepts it in its current condition.






